



UNIFIED AV SYSTEMS (UAVS) FORMED BY MERGER OF INDUSTRY LEADERS

Atlanta, GA, Charlotte, NC – Unified AV Systems, Inc - June 6, 2011 – Multi Media Services (Atlanta, GA) and Video Systems of the Carolinas (Charlotte, NC), today announced their merger to form Unified AV Systems, Inc. (UAVS). UAVS is now the dominant professional audio-visual (ProAV) integrator in the US Middle Atlantic region. The company is headquartered in Atlanta, GA with major operational centers in Charlotte, NC and Greenville, SC, as well as additional sales and technical support offices in Raleigh and Greensboro, N.C. Jim Pressley will serve as UAVS's CEO and Bruce Banbury as President of the firm.

After many months of planning, the merger combines 55 years of operation as separate closely held businesses to form a single, integrated ProAV powerhouse. UAVS remains employee owned, but has expanded employee participation by implementing a broad-based Employee Stock Ownership Program. When we added the strength of employee ownership and a resurgent Southeast economy the merger logic was compelling." The company's strong operational presence in North Carolina, South Carolina and Georgia will be particularly pronounced in the video conferencing, education and corporate sectors. UAVS emerges as the full-service ProAV provider for markets in the region.

Prior to the merger, both companies had strong balance sheets and a history of profitability during a difficult down economy. Mark Fennell, UAVS CFO, sees the company's financial strength as a major asset. "Our strong financial history is what encouraged SunTrust Bank to partner with UAVS providing financing for the transaction." Fennell notes, "We look forward to a long association with SunTrust Bank as our financial partner. Our strong financial backing is a major asset in the marketplace."

Each company brings veterans with dynamic sales and technical teams to UAVS. "Combining these quality-driven talents from both companies will set the stage for even more strength and progressive growth in the Southeast region", said UAVS VP of Sales and Marketing, Keith Taylor.
